

**CONTRACT**

**BETWEEN**

**SOUTHERN STARS FOOTBALL CLUB (AUSTRALIA)**

**-AND-**

**MATCH WORLD LIMITED (UNITED KINGDOM)**

**Contract** made in Melbourne, Australia, on June 27, 2013, by and between:

**Mr. Tony Kiranci** President of **Southern Stars Football Club** based in Melbourne, Australia will be hereinafter referred to as "**Party A**"; and

**Mr. Sanjay Krishna Ganeshan** Director of **Match World Limited** based in United Kingdom hereinafter to as "**Party B**"

## RECITALS

WHEREAS **Party A** is a football club based in Australia participating in the state of Victoria Premier League wishes to hand over its power **Party B** to manage and administer Southern Stars Football Club till September 5, 2013. **Party B** in return agrees to settle outstanding arrears of \$ 250,000 (Australian Dollars) of **Party A** before July 1, 2013.

NOW THEREFORE, in consideration of mutual undertakings herein contained the Parties hereto agree follows:

**ART 1:-** The recitals constitute an integral part of this agreement.

**ART 2:-Party A** will hand over the complete power to **Party B** in the administration of its football club with effect from July, 2013.

**ART 3:-Party B** agrees to settle a sum of \$250,000 (Australian Dollars) outstanding in arrears of **Party A** by July, 2013. **Contract** made in Melbourne, Australia, on June 27, 2013, by and between:

**ART 4:-Party B** agrees to deposit a sum of \$150,000 (Australian Dollars) to **Party A** to ensure it will take over and make the balance payments by July 1, 2013.

**ART 5:-** In the event of a default in balance payment of \$100,000 (Australian Dollars) before July 1, 2013 or the initial deposit of \$100,000 (Australian Dollars) belonging to **Party B** will be forfeited by **Party A**.

**ART 6:-Party A** agrees to hand over the discretion to **Party B** to manage and run all football activities of the Men's 'A' team during the period mentioned in this agreement.

**ART 7:- Party B** agrees to pay the salaries of all visa registered players and provide them with accommodation during the contract period.

**ART 8:- Party B** agrees to comply to manage the club within **Federation Internationale de Football Association** and **Australian Football Federation** rules and regulations during the term of contract.
