I Darya Pishchalnikova, appeal to these organizations, to deal with my situation in a centralized training with the national team of Russia under the leadership of head coach and Maslakova prizident federation Balakhnichev about my sample from May 20, 2012, № 553, is not my fault that that there have found an illegal drug, and I have proof.

Since 2007, the conditions for the Olympic Games, the World Championships in Athletics Russian team is dictated by the leadership of the Federation President VV Balakhnichev, head coach and Vice Maslakova VM Melnikov AV, in collusion with the Russian Anti-Doping Laboratory headed by Director Rodchenkova GM Team members who have the opportunity to win medals in senior competitions prepare for a special scheme developed Maslakova VM, Melnikov, AV, and looked after by the substitution of an A Sample Rodchenkova GM Conditions are established leadership team, led by Maslakova - athlete pays for each sample of 20 thousand Melnikov and 30 thousand Rodchenkova and then with your sample will be all right, you do not pay, with your breakdown can happen anything, as an example my case!

May 20 sample was negative, and standing for 5 months unfilled in October was positive! For the money, the FSUE Rodchenkova ADC produces substitution tests.

29 December 10 my coach called Melnikov AV and said (recording the conversation is) that in Lausanne in your sample of 20 May found the thousandth part of an illegal drug, we were summoned to Moscow. We wrote a letter to Wade his innocence and autopsy samples B. The question Melnikov AV, Maslakov VM, as it happened with my sample, AV Melnikov said that the director of the Laboratory Rodchenkov gm, all positive samples And where are the prohibited substances on the WADA request of May 20, replaced, and thy did not, as it is clean, but this document can not have two months despite the publication of a press release on December 19, 2012 of the Ministry of Sports. And so to prove my innocence as well as other national team athletes Russian athletics who have to prepare for the same scheme on the banned drugs were out of ignorance (the athlete does not have access to the lab), what happens to our samples, please open the B sample for May 2012 other athletes who Rodchenkov gm did not have time to replace, because they do not imagine that they, too, will

demand to Lausanne! This confirms the recording of the telephone conversation with Melnikov.

Due to the fact that I might be in Clive obvyanit it will prove what I say pravdu. Proby B are positive in Lausanne. I want to cooperate with WADA because I was disqualified in 2007. For the substitution of samples are not compromised by Katori as it occurs between rukavodstvom fidiratsii and lab director. I just want to protect their dignity.
