\* ADRV indicates an anti-doping rule violation, in other words confirmation that an athlete has broken anti-doping rules;

\* IC indicates 'In Competition'; and OOC indicates 'Out of Competition'.

\* DCF stands for Doping Control Form

\* TUE stands for Therapeutic Use Exemption
