- \* IC indicates 'In Competition'; and OOC indicates 'Out of Competition';
- \* DCF stands for Doping Control Form;
- \* TUE stands for Therapeutic Use Exemption;
- \* LIMS stands for the Laboratory Information Management System retrieved from the Moscow Laboratory;
- \* CRA stands for Case Resolution Agreement
- \* ABP stands for Athlete Biological Passport
- \* CAS stands for Court of Arbitration for Sport
- \* TNA is Italy's anti-doping tribunal
