* IC indicates 'In Competition'; and OOC indicates 'Out of Competition';

* DCF stands for Doping Control Form;

* TUE stands for Therapeutic Use Exemption;

* LIMS stands for the Laboratory Information Management System retrieved from the Moscow Laboratory;

* CRA stands for Case Resolution Agreement

* ABP stands for Athlete Biological Passport

* CAS stands for Court of Arbitration for Sport

* PNA is Italy's national anti-doping prosecutor; TNA is Italy's anti-doping tribunal

* ABCD is Brazil's anti-doping agency

* AAA is American Arbitration Panel
